
Our first board meeting is Wednesday, September 15 at 6:30pm at New Jersey Blood Services in New Brunswick. Hope to see you there!

Region II Caucus Meeting

This summer, from July 27 to 31, I had the privilege of attending the 78th ASCLS Annual Meeting in Anaheim, CA as New Jersey's student delegate. Each year the meeting coincides with the ASCLS/AACC Clinical Laboratory Expo, which, with over 600 companies displaying their products, is the largest clinical laboratory expo in the world. My first day at the meeting was dedicated to exploring the large number of booths at the expo and learning about the latest products, services, and other technological advancements available for the lab. After the expo, the First-Timers' Reception gave me an opportunity to meet with other students from around the country, as well as more established members of ASCLS.

The next day began with the presentation of industry awards, followed by an opening keynote lecture about the evolution of molecular respiratory viral testing methods. After the keynote, I went to the first Student Forum meeting. At this meeting we discussed ways to increase student membership and involvement in ASCLS. After the Student Forum meeting I attended several more lectures: one about providing the face of the medical laboratory profession, one about the severity of the 2009-2010 Influenza season, and one presented by the CLS People to People delegation about healthcare and laboratory medicine in China.

My first lecture on Thursday dealt with advancements in automated molecular testing. Then after a few more hours at the expo, I went to another Student Forum meeting where we elected the National Student Forum officers for 2010-2011. Next, I attended a lecture about antimicrobial susceptibility testing and a presentation about the US Biovigilance Network, which provides surveillance of adverse events caused by blood transfusion and organ transplantation. Later that evening there was an awards ceremony honoring some of the exceptional members of ASCLS. New Jersey's own Susan Kusic was honored.

Early Friday morning I attended the Region II Caucus meeting where we discussed the budget and planned for the upcoming year. The rest of the afternoon included some of my favorite lectures of the meeting: one presenting unusual microbiology case studies, one discussing the development of and problems with artificial blood and universal RBCs, and another, given by the Los Angeles County Chief Medical Examiner, which featured case studies illustrating the various techniques for human identification and cause of death determination. Then after watching several ASCLS members present their case studies and research projects, I attended the closing keynote speech by Valerie Ng, PhD, MD. Dr. Ng emphasized the important role that we as medical laboratory scientists play in providing quality healthcare.

New Partnership Leads to Record Enrollment



Starting September 7th, 2010, the Florence M. Cook School of Medical Laboratory Science at Jersey Shore University Medical Center (JSUMC) in Neptune, NJ will welcome its largest class in the history of the program. Twenty new student interns will be attending classes. Working through a federal grant for training allied health careers, Brookdale Community College (BCC) has forged new clinical affiliations with Meridian Health. The new affiliations will fulfill specific obligations of the grant for clinical training including a 2-year Associate Degree in Medical Laboratory Technology (MLT) program.

The MLT students began with their pre-requisites at BCC in Lincroft for the first year. Then they move on to career courses for 11 months at the Florence M. Cook School of Medical Laboratory Science, at JSUMC. The MLS and MLT students will be attending the same didactic lectures, but their examinations will vary slightly. The MLS students will do their clinical rotations at JSUMC's clinical laboratory while the MLT students will rotate through the clinical phase of their training at Meridian Health's other clinical laboratories.

The Florence M. Cook School of Medical Laboratory Science at Jersey Shore University Medical Center has been training medical laboratory scientists for over 60 years.

Students come from affiliated universities with a minimum of three years of preparatory pre-requisites or have a BS degree from non-affiliated schools. After successful completion of the program, graduates qualify to take the national certification examination administered by the Board of Certification (BOC). Once they complete the program, each MLS student receives a certificate, which is credited towards a BS degree in Medical Laboratory Science/Medical Technology from their home universities. Students with a BS degree upon entering the program receive a certificate in Medical Laboratory Science. MLT students will receive an Associate in Applied Science degree in Medical Laboratory Technology from BCC.

In regards to future generations of ASCLS-NJ members, I continue to especially encourage young graduates to take an active role within this constantly growing community by attending the Annual Meetings. These events can certainly give us a closer view of ASCLS as a governing body, whose decisions reflect and uphold the voices of its passionate members and the integrity of our profession as a whole. This "congress" of laboratory professionals can only be as efficient as the delegates who make up this assembly. So continue to challenge yourselves because there is always room for growth and success.


