Model1

All your financial transactions via DI-Automobile GmbH. We will buy your car, in our name, at any dealer for you. You buy the car from us for the same price + 3% handling fee (min 1.500 for cars cheaper than 50.000EUR net). 20 years of experience and trust.

The contract will be between you and DI-Auto.

Model2

All your financial transactions via a lawyer or law firm. We (DI-Auto) can recommend a law firm or you can choose.

We will buy your car, in our name, at any dealer for you. You buy the car from us for the same price +4% handling fee. Min. 2.000 EUR for cars cheaper than 50.000EUR net. Additional layer of security for you if you wish. Lawyer will only release the money to us after your confirmation.

The contract will be between you and DI-Auto.

Model1 and Model2

- -Balance has to be paid, **only before** the car is loaded for shipping after you or your shipping company has confirmed that they have received the car. Please mind, the car will only be allowed to be loaded after we / law firm has received final payment. Bank transfer might take several days.
- -Extra services required by you must be paid before separately.
- VAT deposit / security, will be paid back as soon as your car has arrived in your country and you send us the required documents. Without these documents DI-Auto has to pay 19% VAT to the German tax department.

Note:

- We try to deliver the car as quick as possible to your Shipper. Delays may occur if manufacturer does not deliver the required documents on time or if import regulations of your country require alternative documents and permits. This is not in our hand.
- We can only give you an offer with prices at present day but have no influence of price development in the future.
