## **WARNING & PRESS RELEASE**

**WHY AM I BEING ATTACKED? THE SYSTEMATIC ATTEMPT TO RUIN ME AND STEAL LYNX!**

For years, I have been systematically attacked – through defamation, false accusations, stolen mail, and now the theft of multiple vehicles over the years, including a Jaguar C-Type from Browns Lane. - The most recent theft occurred at Browns Lane, where a Jaguar C-Type was taken from my workshop.

- This tenant was also previously renting the workshop before I took over the lease, a fact that was deliberately concealed from me.
- I later discovered that I was paying nearly double the rent that this tenant and his business partner had paid before me.
- This was another calculated maneuver to exploit me financially while setting me up for further sabotage.

## **3. TARGETING MY INVESTORS & CUSTOMERS THROUGH DEFAMATION**

- Not only have these individuals stolen from me, but they have also deliberately sought to destroy my business and reputation by targeting my investors and customers.
