## PRICE POLICY

**One trial training** per sport is for free for everybody. Please register for a trial training via [training@ttg-hamburg.de](mailto:training@ttg-hamburg.de).

If you do not want to become a member, you can also train as a guest. Guest pay 8–10€ per training. You can also get a 10-sessions card. If you are training as a guest for several months we would suggest a membership. Which courses are run by donations can be found on our website ([www.ttg-hamburg.de](http://www.ttg-hamburg.de)). You do not need to become a member if you only attend courses that are run by donations. Please get in touch with the gym if you want to attend a training: [training@ttg-hamburg.de](mailto:training@ttg-hamburg.de).

**The general membership fee** includes the fees for sports insurance of the Hamburger Sportbund e.V. (HSB) and the GEMA in the amount of the rates set by the HSB. If a member does not pay the fees for 2 months, the board may expel the person from the association if the fees have not been paid after 3 requests. After the exclusion, the outstanding amount must be paid.

**Dormant membership:** If you are unable to train for **at least 2 months**, you can apply for a dormant membership one month in advance. The monthly course fee will then be suspended and the basic fee will be reduced to 4€ during this period. Valid reasons: pregnancy, illness or injury, stay outside of Hamburg.

**Price policy:** The membership fees finance our running costs such as salary for the trainers, rent, materials, insurance, office supplies, etc. We want to offer you good training, equipment and premises and to be able to manage the gym properly. If you can pay more per month we are happy about a higher monthly contribution so the gym can develop in the future. If you pay a higher fee you will also support access to sport for people who cannot afford the lowest price.

**The admission fee** is 15€. The fee will be collected once with the first contribution.

**Direct debit mandate:** the membership fees will be debited monthly on the 10th. Return debits due to insufficient funds cost us bank fees. We will re-collect debit entries that have been cancelled approx. 2 weeks later (fee plus bank fee).

**Cash pay:** donations for courses as well as guest fees and 10-sessions cards can be paid in cash.

The **resignation** from the club needs to be communicated to the association in writing with a two-month period of notice to the end of a calendar month. If this period is not observed, the member undertakes to pay the outstanding amount.

Members are obliged to communicate **changes in address, contact details and bank account** immediately to [mitgliederverwaltung@ttg-hamburg.de](mailto:mitgliederverwaltung@ttg-hamburg.de). If changes are not communicated, the association cannot suffer disadvantages as a result.

**Supporting memberships** have the same notice period as other memberships. According to § 4 number 2, supporting members have no voting rights at the general meeting and cannot participate in the sporting exercises and other offers for club members. The amount of contributions for supporting members is at least 20% of the regular monthly fee (= 7€).



## AGREEMENT TO THE STORAGE OF PERSONAL DATA ACCORDING TO DS-GVO

With the following agreement, I declare my consent that Tyger Trimiar Gym e.V. may contact me by e-mail, mail or telephone about relevant club-related information, in response to my inquiries and about event invitations.

Furthermore, I agree that the information on the membership form, such as my first and last name, address, date of birth in connection with my e-mail address, and the information on my SEPA direct debit mandate will be collected, stored, used and, if necessary, changed by Tyger Trimiar Gym e.V., in order to guarantee the administration of my membership in the association and all communication with me. The data will be stored both in paper and digital form to guarantee the club membership administration. It is ensured that the data is protected from access by unauthorized third parties. The data will not be passed on to third parties. Only the office staff and

the treasurer have access to the data. I can at any time obtain information about the data stored about me (Article 15 DSGVO), have it corrected (Article 16 DSGVO) and have it deleted (Article 17 DSGVO). Furthermore, I have the right to restrict processing (Article 18 DSGVO), the right for data portability (Article 20 DSGVO), the right to object (Article 21 DSGVO) and the right to lodge a complaint with the supervisory authority (Article 77 DSGVO). I can request the implementation of the rights towards Tyger Trimiar Gym e.V.
