

Website Privacy Policy Urban Vybez Radio Ltd

We want to inform you about what personal data is collected when you use our website, how your data is processed and the rights you have regarding your data. We have summarised this information for you below.

Information about the collection of your personal data

Your rights as a data subject

Right of access

You have the right to obtain information from us about the categories of data stored, the purpose of processing, the recipients of the data, the planned storage period and your rights regarding data protection. For personal data not collected directly from you, you have the right to be informed about the source of the data.

Right to rectification

If the personal data we process is inaccurate or incomplete, you have the right to have your data rectified.

Right to erasure

You have the right to request that we delete your personal data. In certain cases, however, your data cannot be deleted. For example, if your data is required for an active contract or for our accounting and statutory responsibilities.

Right to restriction of processing

You can request that we restrict the processing of your data in the following cases:

- You have disputed the accuracy of data and you want us to stop using it pending final verification;
- The processing is unlawful, but you would prefer to restrict processing rather than have the data erased;
- We no longer need and would otherwise delete the data, but you still need it for the assertion, exercise or defence of legal claims; or
- You have lodged an objection to the data processing, which is still under review.

In the event of a restriction, we will ensure that the personal data cannot be further processed or changed by us. If processing has been restricted in accordance with the above conditions, the controller will inform you before lifting the restriction.

Right to data portability

You have the right to receive the personal data that you provided to us in a structured, commonly used and machine-readable format and, if necessary, to have it transferred to third parties.

The right to data portability shall not apply to processing that is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.

Right to object

You have the right to object at any time to the processing of personal data that we process on the basis of a "legitimate interest"; this also applies to profiling based on these provisions.

We will then no longer process your personal data unless we can demonstrate compelling legitimate grounds for the processing that override your interests, rights and freedoms, or unless the processing serves to assert, exercise or defend legal claims.

You can object to data processing for the purpose of direct advertising at any time without providing a reason. If you object to processing for direct marketing purposes, your personal data will no longer be processed for these purposes.

To exercise your right to object, you must submit an objection to us, the data controller at urbanvybez@yahoo.com

Right to withdraw

You have the right to withdraw your consent to future processing at any time.

Right to lodge a complaint with a supervisory authority
