- The Workplace (Health, Safety and Welfare) Regulations 1992
- The Fire Precautions (Workplace) Regulations 1997
- The Provision and Use of Work Equipment Regulations 1998

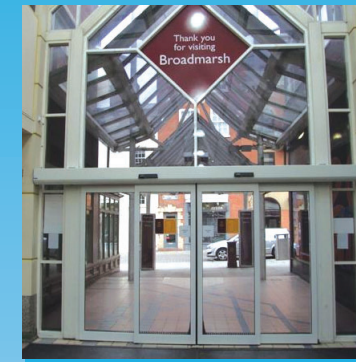
DECLARATION OF INCORPORATION

Our preventative planned maintenance is designed to prolong the longevity of any make or type of door and ensure their continued safe and reliable use. This is particularly essential for emergency exits and escape routes. This service consists of a 20 part checklist, advising on the condition of your doors, and if necessary recommend improvements. The service is undertaken by fully qualified engineers and provides the reassurance of being fully certificated to British Safety Standard (BS 7036) and complying with insurance requirements.

THE DISABILITY DISCRIMINATION ACT

We also offer practical solutions to comply with the Disability Discrimination Act. Under the DDA businesses have to make reasonable adjustments so they do not discriminate against disabled customers or employees.

The law has been designed so that you only have to make reasonable changes (in most circumstances existing doors can still be used), but if you fail to do so, a disabled person could take legal action against you for treating them unfairly. Also if your organisation is not accessible to disabled people, then potential customers are being lost.
