General terms and conditions as of 1st Jan 2024

These terms and conditions apply to the contract on commission. Please read the terms and conditions carefully and contact us if you have any questions.

Acceptance regulations

We take goods on commission and will offer them for sale to our customers.

Condition for acceptance of clothes and shoes

- Clothing up to size 140, maternity wear from 34, shoes up to size **30**
- washed, ironed, with closed buttons **without** stains and defects, perfect soleplate

Requirements for the acceptance of toys, vehicles and large parts

- Toys must be in a clean, complete and fully functional condition.
- Electronic devices or toys must be equipped **with** a full battery

The goods are checked by us directly upon delivery and we decide which goods are to be included in the assortment. (We reserve the right not to accept clothing from KIK and food discounters). Goods delivered to the commission can only be checked by us to a relative extent. We cannot give any guarantee for completeness and functionality of offered goods or for returns.

The selling prices are determined by us, for higher quality articles the price is agreed upon with the customer at the time of delivery.

Acceptance only **Tuesday** and **Saturday with appointment** (or by prior arrangement by telephone)

Important!!!!	A maximum of 40 articles are accepted per submission (maximum 160 articles per year)	

For large items such as play kitchen, car seats, travel beds, etc. we ask for prior telephone arrangement! Delivery of rainwear, rubber boots, mud pants and initial equipment (bottle warmer, nursing pillow, bed accessories, car seats etc.) is always possible.

Sales regulations

The goods are offered for sale for **at least** 3 months.

The customer's share of the sales price is 50 %, from an article sales price over 30,- € it is 60 %.

Customers have the possibility to renounce the return of unsold goods and will then automatically receive 60% of the sales price on all sold goods! The unsold goods are then donated to charitable organizations.

Furthermore, I reserve the right to sell individual parts via EBAY at the agreed selling price.

Return policy

Goods that have not been sold must be picked up by the customer within the above return period.

The pick-up date will be shown on the item listing. There will be a specific pick-up period by e-mail as soon as the goods are ready for collection.

If the goods are not picked up after receipt of the e-mail for return, the customer waives the right to return the goods. For goods displayed and offered here in the store, we cannot guarantee the completeness and functionality of the goods in case of non-sale and return.
