How to do train-transports to Ukraine

Train companies want to pull waggons

Train companies want to pull waggons

Their price liste refers to tons and kilometers

Train companies HATE all kinds of loading !!!

That needs stations, staff and trains do not roll during loading – therefore they HATE loading

If you offer them deloading from 1.520 mm and loading onto 1.435 mm - they will NOT do it !! – you have to organize that yourself

If you ask them to deload Containers and load them onto another train – OK that is possible in some containerport locations

Best you can offer an old stiff train company Is: pulling waggons on only one track-size ... But building 1.435 mm tracks will take time!

Life and War is NOW – we have to transport now !!!

Grain-Train-Ukraine is a "CONTAINER Train" – with many many 20 ft Bulk and few 40 ft Containers on.

Grain and Coal in the same containers !? – makes a darker bred, but does not hurt anybody ... ist OK

Containers have side doors – you can put in building materials – but containers are too small for tanks ...

Grain-Trains-Ukraine **IS A PROGRAMM** – funded by EU it begins to buy grain at TABLE PRICES and it sells grain to table prices. – Container grain to be precise.

Lets put a few Container-Trains together - following the Grain-Trains-Ukraine plan. - **Strictly follow plan.**It is a "**Train-Standard**" – all GTU trains are combined in the same order. They are tailored to Ukraine needs.

The concrete sleeper elements are transported on the open platform waggon every Grain-Train-Ukraine got.

Since August, 12 Mio. tons of grain have been transported from Odessa Harbour – Congrats to Ukraine railway to bring such amount there.

That is 3 Mio. tons / month – Train to Harbour / Ship

Now us. Each Grain-Train-Ukraine does 2.475 ton net

3.000.000 tons: 2.475 tons/trains = 1.212 trains/month

1.212 trains : 4 lanes : 30 days = 10 trains/day/4 lanes10 trains/day – that is still a big EU transport program

As each train takes 2 days to reach EU harbour and 2 days back then (passenger trains have priority on Railway nets) = 10 trains x 4 = 40 EU trains at work

It is a question of min. half a year to bring that on full capacity - with 40 trains rolling — Starting with 1 train to collect experience, and to develop the staff-teams to operate 40 Grain-Trains-Ukraine all year(s) around. — Then we drive the UA grain 1.500 km further by train then now - to keep UA alive. OK?

As long as track sizes are different, we NEED to Deload and Load Containers by Kongskilde grain Blower sets. – under the few existing container Ports - Containers can be deload and loaded ...

- A. 1.520 mm Grain Waggon deloaded into Containers on 1.435 mm Waggons only possible with Kongskilde
- B. Container on 1.520 mm Waggon is deloaded onto Waggon on 1.435 mm track only possible with both Container-Bridge Station OR the fork-lift like vehicles used in many harbours and on many storage sites ...
- C. Driving deep into Ukraine on existing and newly to build 1.435 mm tracks. A certain challenge, not to become war combatant doing that. But we deliver concrete sleepers Private companies can drive deep into Ukraine. There is already EU companies operating in Ukraine for so many years. We have to connect UA more to Europe (west), because Ukraine stopped being connected to: north, east and by the war to south side.

Please pay the Grain-Trains-Ukraine Planners for that they work with a budget.
