## The type of personal information we collect

The company (EWS Ltd) collect data from our schools to ensure that we have the school details and confirmation of booking. Our CRM is not aimed at school business where we make direct contact with the schools to confirm bookings, including: numbers of participants, list of food allergies and intolerances and health considerations for the students. We do not require or ask for lists of student names before arrival at camp or activity weeks, days or sessions.

The school booking form is kept in an secure office that only the company directors have access to and all written data collected is stored on this way within the accounts office. For soft copies they are forwarded to the director in charge of data security and deleted form any emails or logs and stored in a secure private Apple net work. No data for any students is kept on a digital site that can be used by team members or any member of the public.

We do not collect and store data when it comes to students, no name, age, home location, emails or any data that can be used against them. We meet the children with food intolerances and health conditions personally on site with the teachers, making sure that the camp and activities are safe for them.

We keep the email addresses from the school on an apple data base, with school address and our contacts name and telephone number. We do not keep any personal data about teachers on our CRM or in any of the programs that we use. At no point do we ask for date of birth, passport details, driving license, home address or any other private material.

## Company statement regarding school children.

At no time do we endeavour to collect the names of school children and their information. We do not process children data and the accident books are completed with a teacher with our copy is stored with the Director in charge of data management in the secure directors office. We do not share our school data with any third parties. Photographs of students may only be used by express permission of the school and child's family. We ask the school for pictures that we may use and have a policy of no pictures unless previously agreed with the school and even then we attempt to keep the face of children out of frame or very distant.
