### **Membership Contributions;**

All members are required to make an annual contribution to the Organisation. There are three rates;

### The rates are:

- Full; The Medway Band; £240 per year; Medway Concert Brass; £180
- If any member has any difficulty in meeting the Full rate, they may apply to the Management Committee in writing outlining their difficulties and applying for a reduced rate. A member of the Committee will speak with the member concerned confidentially to discuss an appropriate level of contribution this will be agreed by The Management Committee. All such discussions will be treated with the strictest confidentiality and only between the member concerned and the members of the Management Committee. The contribution will be reviewed annually, and the member will be required to pay the Full rate when the member's circumstances have improved sufficiently.

# **Virgin Money Giving**

All member contributions should be paid online via Virgin Money Giving. This way, Gift Aid is automatically secured on all contributions.
