AROUND the LAB by Mike Starch

Most of the formulators who read this column will have seen a formulation with the notation "q.s.". This is a term that is also used by pharmacists and it is short for the Latin expression "quantum satis", which translates to "as much as is sufficient".

Often in a written formulation, the amount of water needed will be expressed as "q.s. to 100". This means to use enough water to bring the total of all the ingredients to 100%.

When I document a formulation, I usually specify the percentage of water that is needed. I find this more helpful because it provides an easy check to make sure that I haven't forgotten anything (all of the percentage should add to 100%)

In other cases, q.s. may be used for the amount of other ingredients such as fragrance or preservative. This indicates that the formulator needs to determine the "sufficient" amount for themselves based on the requirements of the formulation. A moisturizer intended for use on the face needs a lower concentration of fragrance compared to a hand & body lotion. And the level of preservative may need to be adjusted depending upon how "clean" the raw materials and packaging are for the particular manufacturing situation. THE EDITORS
