### Realities:

Critical Infrastructure(s) are the foundation and enabler of the spectrum of American Life. The safety, security, quality of life and future of every American and the Nation itself, rests on our infrastructures. In an inextricably cyber-reliant America, with the growing global exploitation of them and beyond "SMART", America's critical infrastructures must be made and kept operationally resilient or "SMART-R<sup>®1</sup>." The continuing failure to make our infrastructures operationally resilient guarantees consequences unprecedented in scope, intensity and duration. Continuing iterations of 1990's era infrastructure protection and security efforts have proven themselves incapable of meeting the threats to our increasingly cyber-reliant critical infrastructure(s). Thus, moving beyond the comfort of the status quo is an immediate priority and National imperative.

The AIRNPC sees The National Infrastructure Bank as playing both an advanced and pivotal role in a creating a new, objectively measurable and sustainable resilience-based standard of business, community and National Preparedness. Specifically, the implementation of a unifying, objectively measurable standard of Infrastructure, community and ultimately, National Preparedness. To that end, infrastructure resource requirements must come from American Communities – the people and localities where all cyber-reliant and interdependent infrastructure operations naturally merge.

Mayors, infrastructure providers, businesses, and community requirements in infrastructure investment are triaged and validated by local and state authorities for submission to the Federal Government. The execution of Federal infrastructure resources is then overseen by the US Government and administered by the National Infrastructure Bank.

In this Private Public Preparedness Partnership (P4), businesses, local authorities and State governments take central stage. They collectively provide and validate "ground truth"-based infrastructure requirements to ensure the provision and sustainment of resilient infrastructures Nation-wide.
