RESOLUTION 2011-A-6

A RESOLUTION

OF THE BOARD OF THE WEST HANOVER TOWNSHIP WATER AND SEWER AUTHORITY PROVIDING FOR THE FIXING AND CHARGING OF SEWER RATES FOR USE OF THE SEWAGE COLLECTION, TRANSPORTATION, AND TREATMENT SYSTEM. THIS RESOLUTION CODIFIES AND SUPERSEDES RESOLUTION 1995-A-49, 1996-A-5, 2001-A-5, 2004-A-4, 2005-A-4, 2006-A-6, 2007-A-4, 2008-A-5, 2009-A-5 AND 2010-A-6.

WHEREAS, the Authority, with the approval of the Township of West Hanover, Dauphin County, Pennsylvania, has acquired and constructed a sanitary sewage collection, transportation and treatment system, including all related and necessary facilities, for rendering sewage service in and for a portion of the Township; and

WHEREAS, the Authority desires to establish sewer rates appropriate to owners of property connecting to said Sewer System; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of the Authority, as follows:

SECTION 1. The Authority hereby determines that, as of January 1, 2012, the monthly sewer rate for Domestic Establishments, as defined in Resolution 2004-A-4, shall be \$624 per annum, or \$52 per month.

SECTION 2. The Authority hereby reaffirms that, as of January 1, 2012, the monthly sewer rates for Non-Domestic Establishments, as defined in Resolution 2004-A-4, shall be \$624 per annum per EDU, or \$52 per month.

SECTION 3. The Authority hereby reaffirms that, as of January 1, 2012, the monthly sewer rates for Non-Domestic Establishments, as defined in Resolution 2004-A-4 and utilizing water meters to determine water usage, shall be \$9.63 per 1,000 gallons.

SECTION 4. The above fees charged by the Authority pursuant to this Resolution shall be payable to such officer or representative of the Authority as shall be authorized, from time to time, to accept payment thereof.

SECTION 5. The Authority, as permitted by law, shall enforce payment of all of the above fees charged by the Authority pursuant to this Resolution at the time in effect.

SECTION 6. This Resolution shall become effective immediately.

SECTION 7. The Authority reserves the right, from time to time, to adopt modifications of, supplements to, or amendments of this Resolution.


