A RESOLUTION OF THE WEST HANOVER TOWNSHIP WATER AND SEWER AUTHORITY, DAUPHIN COUNTY, PENNSYLVANIA, APPROVING THE WEST HANOVER TOWNSHIP WATER AND SEWER AUTHORITY TO PROVIDE SERVICES TO PROPERTIES IN PHASE VI OF THE CREEKVALE RESIDENTIAL DEVELOPMENT, LOCATED IN EAST HANOVER TOWNSHIP

WHEREAS, the Municipality Authorities Act ("MAA"), 53 Pa.C.S. § 5601, et seq., governs municipal authorities in the Commonwealth of Pennsylvania; and

WHEREAS, municipal authorities are generally limited to providing services within the boundaries of their incorporating municipality; and

WHEREAS, Section 5607(b)(3)(i) of the MAA, however, provides an exception that services may be provided outside of boundaries if in relation to a project and the governing bodies of each municipality in which the project will be undertaken evidence their approval by resolution; and

WHEREAS, Phase VI of the Creekvale Residential Development ("Creekvale Project") contains proposed units that run alongside the border of West Hanover Township and extend into East Hanover Township—the proposed units for the Creekvale Project in need of service are depicted in Exhibit "A," which is attached hereto and incorporated herein by reference; and

WHEREAS, the West Hanover Township Water and Sewer Authority ("West Hanover Authority") desires to evidence its approval for the West Hanover Authority to provide service in connection with the Creekvale Project for proposed units located in East Hanover Township.

NOW, THEREFORE, BE IT RESOLVED, by the West Hanover Township Water and Sewer Authority, Dauphin County, Pennsylvania, as follows:

<u>Section 1</u>. The above recitals are incorporated herein.

Section 2. The West Hanover Authority, for purposes of Section 5607(b)(3)(i) of the MAA, hereby evidences its approval through this Resolution for West Hanover Authority to provide service to proposed units situated in East Hanover Township within the Creekvale Project limited to those depicted in Exhibit "A." The West Hanover Authority further evidences its approval for the West Hanover Authority to manage certain connection lines on portions of Kelly Drive and Lenker Drive from the pumpstation / manhole number 0 to manhole number 1; manhole number 1 to manhole number 13; and manhole number 13 to manhole number 14, as depicted on Exhibit "B," which is attached hereto and incorporated herein by reference.

<u>Section 3</u>. This Resolution shall become effective immediately.

Section 4. In the event that any provision, section, sentence, clause, or part of this Resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause, or part of this Resolution.

Section 5. All resolutions or parts of resolutions, of West Hanover Authority inconsistent with the above Resolution are expressly repealed.


