**RESOLUTION 2013-A-2**

**A RESOLUTION**

**OF THE BOARD OF THE WEST HANOVER TOWNSHIP WATER AND SEWER AUTHORITY (AUTHORITY) PROVIDING FOR THE FIXING AND CHARGING OF SEWER RATES FOR USE OF THE SEWAGE COLLECTION, TRANSPORTATION, AND TREATMENT SYSTEM. THIS RESOLUTION CODIFIES AND SUPERSEDES RESOLUTION 1995-A-49, 1996-A-5, 2001-A-5, , 2005-A-4, 2006-A-6, 2007-A-4, 2008-A-5, 2009-A-5, 2010-A-6 AND 2011-A-6.**

WHEREAS, the Authority, with the approval of the Township of West Hanover, Dauphin County, Pennsylvania, has acquired and constructed a sanitary sewage collection, transportation and treatment system, including all related and necessary facilities, for rendering sewage service in and for a portion of the Township; and

WHEREAS, the Authority desires to establish sewer rates appropriate to owners of property connecting to said Sewer System;

NOW, THEREFORE, BE IT RESOLVED, by the Authority, as follows:

SECTION 1. Effective January 1, 2014, the sewer rate for Domestic Establishments, as defined in Resolution 2013-A-1, shall be \$624 per annum per Establishment, or \$156 per quarter annum per Establishment.

SECTION 2. Effective January 1, 2014, the sewer rate for Unmetered Non-Domestic Establishments and Unmetered Multi-Use Establishments, as defined in Resolution 2013-A-1, shall be \$9.63 per 1,000 gallons of estimated usage, except that the sewer rate shall not be less than \$52 per month per Building.

SECTION 3. Effective January 1, 2014, the sewer rate for Metered Non-Domestic Establishments and Metered Multi-Use Establishments, as defined in Resolution 2013-A-1, shall be \$9.63 per 1,000 gallons of metered usage, except that the sewer rate shall not be less than \$52 per month per Building.

SECTION 4. The above fees charged by the Authority pursuant to this Resolution shall be payable to such officer or representative of the Authority as shall be authorized, from time to time, to accept payment thereof.

SECTION 5. The Authority, as permitted by law, shall enforce payment of all of the above fees charged by the Authority pursuant to this Resolution.

SECTION 6. This Resolution shall become effective immediately.

SECTION 7. The Authority reserves the right, from time to time, to adopt modifications of, supplements to, or amendments of this Resolution.


SECTION 8. In the event any provision, section, sentence, clause, or part of this Resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause, or part of this Resolution, it being the intent of the Authority that such remainder shall be and shall remain in full force and effect.
