A RESOLUTION OF THE BOARD OF THE WEST HANOVER TOWNSHIP WATER & SEWER AUTHORITY, DAUPHIN COUNTY, PENNSYLVANIA, AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT WITH WEST HANOVER TOWNSHIP, EAST HANOVER TOWNSHIP AND EAST HANOVER TOWNSHIP MUNICIPAL AUTHORITY TO PROVIDE SEWER SERVICES TO THE CREEKVALE SUBDIVISION IN EAST HANOVER TOWNSHIP, DAUPHIN COUNTY

WHEREAS, this Authority was incorporated pursuant to appropriate action of the Township of West Hanover (hereinafter, the “Township”), pursuant to the provisions of the Pennsylvania Municipality Authorities Act, as amended, 53 Pa.C.S.A. §5601 *et seq.* (The “Act”), and;

WHEREAS, this Authority owns and operates certain sewer facilities for the collection, transportation and treatment of sewage (the “Sewer System”) and;

WHEREAS, the Pennsylvania Legislature enacted the Act of December 19, 1996 (P.L. 1158, No. 177, referred to as the Intergovernmental Cooperation Law, 53 Pa. C.S.A. §2301, *et seq.* which provides two or more municipalities may jointly cooperate in the exercise and performance of their respective governmental functions, powers or responsibilities, and;

WHEREAS, the Municipality Authorities Act authorizes Intergovernmental Cooperation, with approval by resolution 53 Pa.C.S.A. § 5607(b)(3)(i) and;

WHEREAS, this Authority desires to cooperate with West Hanover Township, East Hanover Township and East Hanover Municipal Authority to provide services to the subdivision known as Creekvale in East Hanover Township, Dauphin County.

NOW, THEREFORE, BE IT RESOLVED, by the Board of this Authority, as follows:


1. The Authority Board hereby authorizes the Solicitor and staff to enter negotiations to provide an Intergovernmental Cooperation Agreement to provide sewer services to the Creekvale subdivision.
2. The Authority Board hereby authorizes its Chairman and Secretary to sign an Intergovernmental Cooperation Agreement to provide sewer services to the Creekvale subdivision in East Hanover Township.
