A Juried Pottery and Multi-medium Potters' Guild of LC Show

At the Tombaugh Gallery, Las Cruces June 2024 and Deming Arts Center July 2024

Call for Submission

Eligibility: You should be a member of Potters' Guild of Las Cruces.

There are two category opportunities for this show:

- A collaboration between a Potters' Guild member and a fiber artist.
- A Potters' Guild member creating both the clay and fiber art for their entry.

Submission Criteria: Each art piece submitted must be at least (50%) fifty percent clay. Other materials may be fabric, wood, textiles, etc. The submitting artist must be a Potters' Guild member.

Participation Fee: \$25 for one or two artworks entered in the collaboration category
\$25 for one or two artworks entered for the individual category

If a Potters' Guild member is participating in both Collaboration and Individual Categories the fee is \$50.

Calendar:

- *May 1, 2024* Application deadline, postmarked no later than May 1, 2024. The application package includes the application, \$25 or \$50 check made out to the Potters' Guild of Las Cruces. Mail the application to Potters' Guild of Las Cruces, PO Box 3656, Las Cruces, NM 88003 Make Checks to Potters' Guild of Las Cruces.
- *May 10, 2024* photos of completed work emailed to vickiemorrow@msn.com for publication.
- *Wednesday, June 5,* Artworks delivered to the Tombaugh Gallery, 2000 S. Solano Dr.: 9:30 am – 12:00 pm
- *Friday, June 7,* 5-7 pm Exhibit opening and wine reception.
Show will move to Deming Arts Center for a July showing.
If you sell work in the Tombaugh Show it will NOT be taken to Deming. The buyer may pick it up at the end of the Tombaugh Gallery show. You may have a replacement piece for the Deming Show. All Artworks must be for sale. Each gallery will take 30% of the selling price.
- *Sunday, July 7,* Exhibit opens at Deming Arts Center. Reception 1-3
- *July 29,* Exhibit closes at Deming Arts Center, Artwork will be picked up and returned to Las Cruces.

Awards: Show will be juried by an independent juror. Cash awards will be given at Friday evening reception at Tombaugh Gallery, June 7, 5-7 pm.

Note: NO artworks previously entered in Fire and Fiber Shows will be accepted.
