Ripon's Little White Schoolhouse — 'Birthplace of the Republican Party' — Loses National Status

The Little White Schoolhouse, "Birthplace of the Republican Party," located in Ripon, Wisconsin, was moved from 305 Blackburn St. to 1074 W. Fond du Lac St. on Monday, April 17, 2023.

The LWSH was added to the National Register of Historic Places in 1973 and attained National Landmark status in 1974. Although it is possible to move a National Landmark, to retain the historic designations, the LWSH Board was required to present a relocation package and gain approval at the local, state and national level.

On September 7, 2022, the Ripon Historic Preservation Committee granted its approval (based on misinformation) and on January 27, 2023 the WHS Historical Preservation Review Board approved the move and forwarded the relocation request to the National Park Service.

On March 10, 2023, the National Park Service notified the Wisconsin Historical Society (WHS) that "We have determined that the proposed location at 1074 West Fond du Lac Street is not appropriate; we do not approve the move; and the property will be automatically deleted from the National Register if/when moved."

On March 20, 2023, the WHS notified the LWSH Board of the decision.

In the 28 days following receipt of the letter, the LWSH Board of Directors proceeded to dig a foundation and pour a basement at the proposed location, and prepared the LWSH for transport on Monday, April 17, despite the fact that doing so would result in automatic removal from the National Register of Historic Places.

The Devil is in the Details (and He's Been Busy)

There are assertions circulating regarding loss of the LWSH's National designations that we feel are inaccurate or misleading.

Moving the LWSH doesn't matter because it has been moved multiple times before.

Although it is true that the LWSH moved five times previously – the last of which occurred in 1951 – all moves occurred prior to receiving designation on the National Register of Historic Places (1973) and the National Landmarks registry (1974). Once those designations were in place, the owners of the LWSH were required to abide by Code of Federal Regulations (CFR) criteria to retain the National listings.

The March 10 National Park Service (NPS) letter "determined that the proposed location at 1074 West Fond du Lac Street is not appropriate." The letter goes on to explain that "The fact that this property has been relocated in the past does not remove this requirement, but rather makes it even more critical that its current location be maintained."

National Landmark status has not been lost.

Although technically true, this is a disingenuous statement. When the Secretary of Interior's National Landmarks Committee meets, Landmark status will be rescinded. National Register sites and Landmarks must possess the same seven historic integrity aspects – the difference being that Landmarks must possess those aspects to a high degree. Only 2.7% of Register sites are Landmarks. Thus, if a site does not meet basic Registry status, it cannot meet the "high degree" Landmark threshold.

The Republican Party of Fond du Lac County — or Daniel Zimmerman — are responsible for influencing the NPS ruling.

The Republican Party of Fond du Lac County had less than 24 hours notice of the November 18, 2022 WHS Historic Preservation Review Board meeting because WHS did not publish a revised agenda, adding the LWSH, until 24 hours beforehand. After a FDLGOP member discovered the revised agenda, FDLGOP spoke against the move during the public comment session. When the Historic Preservation Review Board tabled a decision until the next scheduled quarterly meeting — February 24, 2023 — plans were made to again speak against the move and write letters to submit to the NPS with the relocation packet.

However, unbeknownst to FDLGOP members, WHS held a single-item special meeting only

for the LWSH on January 27, 2023 and no one from the FDLGOP, including Daniel Zimmerman, spoke or wrote letters against the move at or after that meeting. Furthermore, no letters from the FDLGOP or Daniel Zimmerman were submitted with the relocation packet to the NPS. The NPS dismantled the LWSH Board's request, based solely on criteria outlined in the CFR, without input from FDLGOP or Zimmerman.

Exerting pressure on the NPS to reverse its decision will solve the problem.

The NPS, on behalf of the Secretary of the Interior, follows the guidelines established in the Code of Federal Regulations (CFR), which were enacted by the Antiquities Act of 1906, the Historic Sites Act of 1935, and the National Historic Preservation Act of 1966. The 60-page bulletin "How to Apply the National Register Criteria for Evaluation" outlines the criteria pursuant to moving a property which is listed on the National Register of Historic Places and the National Landmark registry.

"A moved property . . . must retain enough historic features to convey its architectural values and retain integrity of design, materials, workmanship, feeling, and association," (p29). Integrity is defined as "the ability of a property to convey its significance," (p44). There are seven aspects of integrity: location, design, setting, materials, workmanship, feeling and association. Three aspects are relevant to this discussion: location, setting, and feeling.

- "Location is the place where the property was constructed or the place where the historic event occurred." The document explains that "Except in rare cases, the relationship between a property and its historic associations is destroyed if the property is moved." (p44).
- "Setting is the physical environment of a historical property. Setting refers to the character of the place in which the property played its historical role. It involves how, not just where, the property is situated and its relationship to surrounding features and open space." (p45)
- "Feeling is a property's expression of the aesthetic or historic sense of a particular period of time. It results from the presence of physical features that, taken together, convey the property's historic character." (p45).

The March 10 NPS letter "determined that the proposed location at 1074 West Fond du Lac

Street is not appropriate." The letter goes on to explain that "The proposed new location lacks the qualities needed to offset the loss of historic integrity caused by a move."

"The location of the schoolhouse during the historic 1854 gathering for which it is celebrated was in the very heart of Ripon, among a mixture of commercial, industrial and residential buildings, as well as institutional ones like churches and schools. The current setting and location at 305 Blackburn Street two blocks from that historic location — remains a mixture of commercial institutional, and residential buildings today." Further, "Remaining in its current location [305 Blackburn Street] will not threaten the integrity of the building in a manner that justifies its relocation and the resultant loss of historic integrity."

Considering the guidance offered by the March 10 NPS letter, the location at 1074 West Fond du Lac Street will never meet the CFR criteria for inclusion on the National Register of Historic Places or the National Landmark registry and a new location which would meet the CFR criteria must be identified.

Exerting pressure on the National Park Service to reverse its decision is asking them to ignore the CFR criteria which would violate Federal code. Nothing short of a change in Federal Statutes which would take an Act of Congress would lawfully allow a reversal of the decision.

The only solution which would allow the National Park Service to reinstate the LWSH to the National Register of Historic Places and the National Landmark registry would be to move the LWSH to an appropriate location, near the downtown historic district and amidst "a

mix of commercial, institutional and residential buildings." A new relocation packet would need to be submitted to the WHS and then, if accepted, to the NPS for acceptance before a move is made.

National Landmark status is unimportant.

The Republican Party of Fond du Lac County is proud of the National designations assigned to Ripon's Little White Schoolhouse. Although Jackson, Michigan and Exeter, New Hampshire have also claimed to be the Birthplace of the Republican Party, Ripon alone had the National designations to validate the claim. The Republican Party of Fond du Lac County places great value on the National Landmark status and feels that losing the National designations would be a great loss to the Republican Party, to Ripon, to our County, State and Nation.

However, we understand that not everyone feels the same way and that the value of National Landmark status is therefore subjective. We are concerned that the LWSH Board may have already concluded that a visitor center with bathrooms, a basement under the building, and room for bus parking are acceptable trade-offs for loss of National Register of Historic Places and National Landmark designations.

If our fears are unfounded, we urge the LWSH Board to seek a new location which would allow reinstatement, even if that would require purchasing property and razing existing building(s) to make room for the LWSH near the downtown historic district and amidst "a mix of commercial, institutional and residential buildings."

Sept. 10, 2022 - FDLGOP, working with the LWSH Board, arranged a meeting with RNC National Committeeman Tyler Bowyer who proposed moving the LWSH to a location on Ripon's east side on which a \$40 million visitor center funded by an RNC-related Foundation would be erected if the Board would accept an all-expenses paid move of the LWSH to that parcel of land. The Board requested a written proposal within three weeks.

Sept. 15, 2022 - RCOC reveals plans to move the LWSH to the Marine Credit Union site. Upon reading of this decision in the Ripon Commonwealth, just five days after the Sept. 10 meeting, Bowyer did not submit a proposal.

Oct. 7, 2022 – After learning that Ripon Historic Preservation Committee members stated that NPS designations would not be jeopardized because the LWSH had been moved previously, FDLGOP contacted a member of the LWSH Board with the CFR criteria surrounding a proposed move. That member indicated that they were unaware of the criteria or that NPS designations might be jeopardized.

Nov. 18, 2022 - FDLGOP spoke against the move at the Wisconsin Historical Society Historic Preservation Review Board meeting on the basis that the proposed location was not a place of honor for the LWSH and the move should not be approved. Members of the Review Board seemed to lack understanding of the term "improve" in relation to NPS criteria when discussing the merits of the new location.

Dec. 15, 2022 - At the FDLGOP monthly meeting, speaker Daniel Zimmerman provided background information and dispelled rumors about the LWSH. Although a private meeting, a BGCA Board member crashed the meeting and was allowed to stay for the sake of transparency.

December 29, 2022 - RCOC transfers LWSH land out from underneath the LWSH to an LLC linked to a BGCA donor.

Jan. 27, 2023 - The Wisconsin Historical Society HPRB met and approved the proposed move. Originally slated for Feb. 24, 2023, the meeting was moved up four weeks and the FDLGOP was not notified of the schedule change.

April 15, 2023 - FDLGOP became aware of the NPS decision and began contacting attorneys, legislators, Republican leaders, and contractors, in an attempt to halt the move until a suitable location had been approved by the NPS.

Editor's note: After reading the March 10, 2023 NPS determination letter. FDLGOP has concluded that the proposed east-side locations, either in Riggs County Park or near the hospital, would also be deemed inappropriate per NPS criteria.

April 17, 2023 – FDLGOP Chairman Bachleitner documented the move using Facebook Live.

April 18-20, 2023 - Bachleitner spoke live with talk show hosts outlining FDLGOP's opposition to loss of historic designations and desire to identify a location that would meet NPS criteria.
