- extra time to run against your own party's opponents, extra money flowing from coffers that could instead be used to defeat democrats, and the short time to bring your campaign into the final stretch. Because this state of affairs will not change in the near future, candidates deal with the fallout.

At the convention and before, countless GOP members asserted that endorsements so early present insurmountable challenges for candidates who still need to work diligently on their campaigns to maximize their effectiveness.

As a result of this fervor, the voices of the Grass Roots were able to add a new rule to the convention protocols — a "No Endorsement" option. (Rule 16, G — lines 1 & 2) "Each voting delegate shall have the option to cast a vote of 'no endorsement' on each ballot for any office." Despite intense and sometimes heated debates and discussions, the new rule stood.

Although many delegates did personally endorse candidates, there were not enough votes to claim endorsements. There were two exceptions: overwhelmingly the delegates endorsed Orlando Owens for State Treasurer, and Ron Johnson in his re-election bid for United States Senator.

In the days following the convention, Paul Farrow, State Chair of the Republican Party, reflected on the event. "The Republican Party was born in Ripon, Wisconsin, of a group of independent thinkers who sought to end the evil of slavery in the United States. To this day,

Wisconsin Republicans are still independent thinkers — and even rabble-rousers — motivated by a love of country and a desire to strengthen our communities through triedand-true conservative policies. These conservative ideals are what unite us, and if we effectively spread our message, they are our key to success in the crucial 2022 elections."

My personal takeaway from the convention was excitement on numerous levels. The attendance broke records — perhaps a precursor to November elections. The intensity of people's commitment to integrity in our elections was palpable. The processes that allowed the voices of the "people" to be heard and respected were solid and reaffirming to everyone. The ability to "agree to disagree" was alive and well and indeed is part of the backbone of our democracy.

And finally, after all was gaveled into adjournment, we delegates could walk away from the proverbial "belly of the beast" (Madison, of course) with a renewed vigor and firm beliefs that we will all rally together on August 10 to support those Republicans who represent us on their way to victories on November 8. I'd like to quote our illustrious Senator, Ron Johnson, who stood before us (exhausted but elated as we all were) in the late hours before adjournment on Saturday night:

"We don't want to see Mr. and Mrs. Pouty Faces on August 10 after the primary — we need to rally and support our candidates who go forward to represent ALL of us!"
