# Supreme Court Declares Ballot Boxes Illegal

On Friday, July 8, 2022, Wisconsin's Supreme Court issued a 4-3 ruling that deems unmanned absentee ballot drop boxes illegal under Wisconsin election law. A voter must return his ballot either through the United States Postal Service or in person to the voter's municipal clerk or a designated alternate site.

Although Wisconsin law sets forth this secure way of voting, the pandemic gave groups a chance to institute illegal voting methods. Statewide, people watched illegal activities and, although they were shocked and angry, it didn't appear that anything could be done to stop the

fraud. At least not for the 2020 election.

This ballot box ruling is definitely a step in the right direction in an ongoing fight to end fraudulent practices like those employed in the 2020 Presidential election.

An appeals court temporarily blocked the order for contests in February, and the ban was in effect for local elections in April. And now, one month before our swing state's primary elections on August 9, this ruling is seen as a huge victory in conservative circles.

In Teigen vs. WEC 2022 WI 64, Supreme Court Justice Rebecca Bradley wrote for the conservative majority, referring to the state statute governing ballot returns. "The key phrase is 'in person' and it must be assigned its natural meaning. In person 'denotes' bodily 'presence' and the concept of doing something personally." Chief Justice Annette Ziegler, Justice Patience Roggensack, and Justice Brian Hagedorn joined Justice Rebecca Bradley in writing a concurrence.

Justice Ann Walsh Bradley wrote a dissenting opinion joined by Justice Rebecca Dallet and Justice Jill Karofsky.
