Customer, at customer's sole expense, shall provide WN a certificate of insurance coverage certifying the existence of general liability insurance coverage.</p>	<p><b>ITEM 220</b> [I]</p> <p style="text-align: center;"><b>SWITCHING TO AND FROM STORAGE/HOLD TRACKS</b></p> <p>Charges shown below will be assessed per car for cars switched into and out of storage. The charges will be assessed in each direction.</p> <p style="margin-left: 40px;">(a) Non-Hazardous Cars..... \$500.00 (b) Hazardous Cars..... \$650.00</p>
