# View From a Supper Club

One of the most charming parts of our northwoods environment is the array of supper clubs we have to enjoy. It is one of many elements that makes our home in Vilas County special. They're a bit more rare in southern Wisconsin but we found a little place in Pewaukee, across from the lake. Michaels has a killer fish fry and you will find us there often on Fridays in the late fall.

Last Friday, I parked at Michaels and walked across the street to take a look at Pewaukee's collection of "big



metal". This yard stores the "Pewaukee Armada". No, not the marina that houses one of Wisconsin's rare "A" Scow fleets; this is instead the wintering yard for the weed cutters that keep Pewaukee Lake usable for boaters.

There are SEVEN of these monsters, for a lake twice the size of Plum and not quite as deep, at 40 feet. You're looking at more than a \$1 million of metal. This is only a part of the cost of fighting Eurasian Milfoil for this lake district. It is a frightening reality for a northwoods guy.

Closer to home, The Eagle Chain has been fighting milfoil for years, at a total cost of reportedly over \$1.8 million. DNR recently informed them that they would no longer be considered for AIS grants, leaving the funding of milfoil control to the lake associations and districts. The good news for them is that they have reduced the size of the infestation to scattered sites totaling about 5 acres. This year they are pulling it by hand with divers to keep up with it and hopefully, to prevent it from spreading again. The cost for this work is \$2,000...per hour.

Eurasian Water Milfoil is expanding throughout our county. Many of the lakes in St. Germain have it and every year, it is found in new lakes. For Plum Lake, our clean boat/clean water crew on our landings is our last line of defense. The workers are well trained college kids and are effective, but they aren't there 24/7. It is up to us to make certain EWM does not get a foothold. Our sweeps for invasives will be more frequent this year, beginning in early June and continuing each month until fall. If it shows up this year, or is here



now, we need to find it quickly.

Sunset views across the lake are always good from supper clubs – a cocktail or two and tranquility is assured...until we get down to the water line...and look below the surface.

Join us this year on our first sweep, as we search our lake for invasives – it takes an hour or two. All of us need to be involved. It is our lake (that means it is <u>your</u> lake too), and this is OUR responsibility.

THE NEST SITES are all ready. West Plum was found and re-anchored but I

have not seen that pair yet. Motel 6, behind the pilings, is in decent shape and that pair is fishing around the pilings. They went on the nest on May 8. Starlight Bay has its pair in residence, swimming around the island which was occupied by a goose. The goose is gone, but no nesting activity yet. The East Bay

platform was ruined by a muskrat and was replaced. The loons were nesting just 3 days after it was anchored on April 30.

### CARLIN LAKE FIGHTS TO KEEP ITS WATER

Carlin Lake, in Presque Isle, a seepage (ground water sourced) lake with extraordinary water quality has been targeted by a large grocery chain that is expanding into bottled water. The threat, by a company started by Trigs, intends to pump and truck out up to one hundred thousand gallons a day from this 155 acre lake. The destination is a bottling plant that the Trig group opened just over the Michigan border" which will bottle and sell

"Carlin Lake Water" which they claim has "magic healing qualities". Carlin Lake was forced to hire counsel and bring legal action, which is still in process. As you can imagine, the cost of legal council is a huge lift for this small lake. The precedent this sets is a threat to every lake in our county. I have been involved with their leadership on this issue and can offer a strong positive reference for their efforts and their need. Many of us are signing on to help. 
#### LAKE DISTRICT UPDATE
