SVUSD Parents/Guardians,

The Governing Board of the Scott Valley Unified District adopted a Resolution on Monday, November 8, 2021, affirming the flexibility afforded to local control as to how universal masking will be enforced. Their priority was to keep kids in school, in-person. The Resolution provides discretion as to the method for enforcement of universal masking.

What does this mean for your child and family? Signage about universal masking will remain in place or increase, students will be reminded to wear their mask, masks will be offered and provided, and no student will receive disciplinary consequences for not wearing a mask.

Layers of safety measures that have been adopted and implemented remain in place, such as frequent handwashing, heightened sanitizing, filtration, ventilation, teaching and learning outdoors weather permitting, and physical distancing to the greatest extent possible, to name a few.

School leaders, staff and the superintendent are working diligently to develop the operational modifications. As you can imagine, our priorities are supporting and educating our students.
