



Instructions for completing this form - Type or print neatly & return the form to the Society

The horse must be microchipped by a Veterinary Surgeon. The completed descriptive must be accurate and meet all FEI guidelines. If it is completed by a competent person, not a vet, then this must be done prior to any microchip implant, as your vet must sign to confirm that the description is a true representation of the animal that he/she is microchipping.

No completed descriptive older than 6 months prior to registration will be accepted.

- If applying to register a foal then enclose one good quality, clear photograph of the animal suckling its dam in addition to point 2 below
- For registration purposes: Enclose six (6) good quality photographs taken in good light of the complete view of the animal on hard ground (two from each side, one from the front and one from the rear) 15cm x 10cm, suitable to fit 2 to one A5 passport page. Computer printouts will be accepted but only if they are clear, not distorted in any way and are printed onto good quality glossy/matt photographic paper only
- 3 Each photograph must have the D.O.B of the animal and the name of Sire and Dam written on the back
- Any outcrossed breeding must include copies of the non-appaloosa parent's Passport,

 UELN/Registration numbers, and pedigree within for it to be included in the foal passport. (ie if one parent is another breed then this will be required before pedigree can be included in the foal passport)
- Enclose the correct registration fee with cheque or postal order made payable to the British Appaloosa Society or complete the card payment section with your details. If you choose Paypal then you will be Invoiced on receipt of the application at the email address you supply

We strongly recommend you keep a copy of the entire application form in case of postal loss.

STANDARD FEES:

Foal up to 6 months old (or 30th November in year of birth) whichever is the later

Members: £25.00 Non-Members: £50.00

LATE FEES:

Applications received after 6 months old or 30th November in the year of birth, up to and including 31st December of its yearling year:

Members Late Fee: £50.00
Non-members Late Fee: £70.00

For all applications made later than the above, or animals that are not being registered by the breeder, the animal will be required to prove parentage by DNA test prior to registration. Contact the Registrar for DNA fees.
